12:00 - 12:15 pm: Welcome - Jerry Sutton, ASAP Chair

12:15–12:50 pm: Community Mobilization Tool Explanation – Jessica Correll, ASAP Co-Coordinator Jessica gave a brief explanation of why Community Mobilization is important:

"Community mobilization engages all sectors of the population in a community-wide effort to address underage and binge drinking. It empowers individuals and groups to act to facilitate change. Part of the process includes mobilizing necessary resources, disseminating information, generating support, and fostering cooperation across public and private sectors in the community. Community mobilization brings together policy makers, opinion leaders, local governments, professional groups, religious groups, businesses, and individual community members."

12:50-1:10 pm: Subcommittee Summary - Angel Traynor, ASAP Coordinator

Angel summarized ASAP's plans for two subcommittees. Descriptions below:

Law Enforcement:

The purpose of this subcommittee is to assist ASAP and APD with compliance checks and building capacity and community support for ASAP and APD initiatives to reduce underage and binge drinking.

- Compliance Checks-drafting letters, delivering awards, analyzing results
- Help formulate ASAP's strategy to enhance law enforcement efforts
- Assist with/attend "Know Your Limit" events
- Help with setting up underage drinking prevention tipline with APD
- Attend Monthly PCRC meetings and report back to coalition?
- Attend liquor board meetings

Community Outreach:

The purpose of this subcommittee is to build capacity for the coalition in general, build community support for the policy strategy and work with local alcohol retailers

- Media relations
- Work with alcohol retailers to help inform/educate about alcohol laws and promote TIPS training
- Help formulate ASAP's alcohol policy and build community support
- Develop ASAP presentation to take out to community organizations
- Help with ASAP social media and branding
- Table health fairs and events
- Help develop content for website

1:10-1:15 pm: Sgt. Amy Miquez *not on original agenda

Amy discussed compliance checks performed the night before Thanksgiving done by the fire marshal. Two establishments, Armadillo's and Harvest were over capacity. Police are trying to enforce a policy where owners must count the number of patrons. ASAP is also trying to investigate how to fill the old Civilian Liquor Inspector positions.

1:15-1:17: TIPS Training Overview – Jessica Correll, ASAP Asst. Coordinator & Angel Traynor, ASAP Coordinator

Angel explained how Jessica and her completed a two day TIPS training and are now certified to train RBS to local on premise and off premise establishments.

1:17-1:25 PM: Naptown Anti-Dope Movement — Adetola Ajayi, African American Community Services Specialist Mayor's office

NAM's goals are to create an outreach program to all people in the city of Annapolis, create a digital marketing campaign, to establish workshops in the community, and to attain 1,000 individuals to sign an anti-dope pledge. NAM currently has about 200 signatures. NAM currently has five PSAs which will premier at their next event on January 26th. A flyer is currently being created. It is at Robinwood Community center from 11am-3pm. NAM's true focus is fatal overdoses, particularly males and females who are African American and 45+.
