Office of Emergency Planning Office recently has gotten involved with the Opioid Epidemic as our county and state has been declared in a State of Emergency.

Safe Stations

Any individual suffering from substance abuse/dependence can go to any police or fire station, at any time, to seek treatment. They will go through an initial intake and Crisis Response will then set up their intake at a treatment facility.

Bed Finder Project.

With the creation of Safe Stations, came the Bed Finder Project. The Bed Finder Project can be accessed on both a website or APP. The APP isn't available to the public yet. Right now, the APP is being tested and transferred to the Health Department for full ownership.

Project will allow finding available treatment much quicker and more accessible!

Bed Inventory – Centers enter bed availability at least twice a day. Each treatment center has a unique registration code. Inventory data is sent to the Dashboard and the Bed Board only if centers enter it.

Bed Board – Primarily used by Crisis Response System. Features: Filtered Searches, Provides Treatment Center Information, “Near Me” Location, Directions.

Filtered Searches – Ex: Treatment facility that only accepts private insurance.

Dashboard – Only accessible to Anne Arundel County and City of Annapolis OIT’s Senior Policy Group (SPG), Shows overview of all bed availability, Data is archived.

What’s in it for the Treatment Facilities & Centers?

There have been some treatment facilities that have been resistant to this project. The response to them has been that the only thing the project is doing is helping your mission.

Hire & Expand Programs – Additional funding allows potential for more services and/or resources

Potential Grant Funding – To be eligible for certain funding participation is mandatory

Fill Underutilized Beds – Application increases visibility of center

How Safe Stations Work

Individual seeking help arrives in fire station
Notify Fire Alarm of Safe Station Call and unit handling
Fire Alarm Notification to Battalion Chief
Medical evaluation within medical scope of practice
Determine need for hospital transport (see checklist)
Crisis Response evaluate in station, or
EMS transport to hospital

Safe Stations Data

Annapolis City – 65 Safe Stations

Anne Arundel County – 462 Safe Stations

Addition Highlights

If someone has a nonviolent warrant, treatment will take priority over the individual serving the active warrant. They will have attend to the active warrant, but after their treatment needs are met.

Fire Stations aren’t exactly set up for safe stations regarding a more comfortable environment for the individual to sit and wait in until Crisis arrives.

Mobile Crisis Stats

Readiness for change is present with Safe Station visits

Percentage of success is higher in Safe Station consumers

62% success in completing treatment from Safe Stations

10% relapse rate with Safe Stations
